



# PIA Scholarship Opportunities for 2010



1. *Professional Insurance Agents of Georgia CIC Scholarship.* A scholarship fund—set up in 1985 by members of PIA of Georgia, The Willingham Marshall Agency, The Hanover Insurance Company, and Donald Kehaya—has awarded an annual scholarship for all five CIC Institutes to obtain the CIC designation. The scholarship covers registration fees for five institutes.
2. *PIA of Georgia/Society of CIC Scholarship.* In the interest of supporting professional education, these scholarship opportunities are sponsored jointly by PIA and the Society of Certified Insurance Counselors. Nine (9) scholarships are available this year. Recipients may select the Institute of their choice.
3. *CISR Scholarship.* Five scholarships, each for a single CISR module. The five recipients may choose the seminar of their choice.

## Guidelines for all Scholarship Applicants

- > Scholarships cover full tuition and books only and are only valid in the State of Georgia.
- > No make-up provision is allowed for non-attended Institute modules or for failure-to-pass grade.
- > Scholarship is not to be used in conjunction with any other scholarship.
- > Scholarship must be used within one (1) year of date of award.
- > CIC scholarship applicant must have at least two years of experience in the insurance industry and/or be licensed.
- > CISR scholarship applicant, in order to achieve the designation, must have two years of agency/industry experience.
- > Employer of scholarship applicant must attach a letter to the applicant's application attesting their willingness to allow the employee to attend Institute(s)/Module(s) (e.g., time away from work, etc.). Applications received without such letter cannot be considered.
